

# Illiana Corridor Study Tier One Public Hearing Summary - Illinois

The Illinois public hearing for the Illiana project took place on Tuesday, July 31, 2012 at the Peotone High School located at 605 West North Street, Peotone, Illinois from 5-8 PM. The meeting was an open house format with a continuous PowerPoint presentation, exhibit boards for review, interactive maps for property details and large scale aerials of the study area to which meeting attendees provided comments, suggestions, issues and concerns. A public forum was held at 6 PM during which time participants could offer verbal comments to a court reporter. The meeting provided information about the Draft Environmental Impact Statement, and presented more details of the A3S2, B3 and B4 corridors. The meeting was attended by **1006 people**, and **130 comment forms** were received.
